On December 1, 2001, the first China Business Top 500 Forum was held in Shanghai. Jing Shuping, Vice Chairman of the Ninth National Committee of the CPPCC, Yu Guangyuan, a leading economist in China were present. Furthermore, leaders of relevant national ministries and commissions and listed companies, such as Baosteel and China Eastern Airlines, were present.



## 百强企业群与百强城市群的战略合作新格局

New Pattern of Strategic Cooperation between CBT500 Enterprise Cluster and **CBD100 City Cluster** 

华顿经济研究院和百强论坛将坚持秉承"做 强做大做优"的核心发展理念、全面推动百强企 业群和百强城市群的协调高质量发展。

中国上市公司 500 强企业在 2022 年度创 造利润总额突破 6.6 万亿, 占中国全部 5000 余 家上市公司总利润的 95%。500 强企业的营业 额超 50 万亿, 与全国 GDP 总量之比达到 41%。 中国百强上市公司当之无愧是中国经济的主力 军。为了更好发挥百强公司主力军的作用, 百强 企业群可按照功能和作用划分为四大梯队集团 军,以便统筹安排百强企业与百强城市及国内外 重大项目的协同发展。

第一梯队是建筑能源类企业、主要包括建 筑、能源、房地产等,上榜企业共119家,利润总 额达到 1.7 万亿元, 占百强公司全部利润总额的 26%。这些企业为国家和地区发展夯实了基础, 是经济社会发展的关键支撑。

第二梯队为制造业企业,是工业化、产业化 的主体, 共有 229 家企业, 利润总额超 1.3 万亿 元,占百强公司全部利润总额的20%。制造业企 业是实体经济的核心, 承担着巩固产业链、促进 经济高质量发展的重要使命。

第三梯队是服务业企业,包括交通、商贸、运 输、通信等,有79家企业,利润总额达7900亿 元,占百强公司利润总额的12%。日益扩大的服 务业规模不仅持续拉动我国城市化、市场化的发 展,同时助力了我国的产业结构升级。

第四梯队是金融业企业,为其他三大梯队提

Warton Economic Institute and China Business Top 500 Forum will adhere to the core development concept of "Stronger, Bigger, Better" to promote the coordinated and high-quality development of China Business Top 500 Enterprise Cluster and China Balanced Development 100 City Cluster.

In 2022, CBT500 enterprises in China generated more than 6.6 trillion yuan total profits, accounting for 95% of the total profits of all listed enterprises in China. The operating income of CBT500 enterprises exceeded 50 trillion yuan, with a ratio of 41% to the total national GDP. CBT500enterprises are deservedly the main force of Chinese economy. In order to better utilize the role of CBT500 enterprises as the main force, CBT500 Enterprise Cluster can be divided into four echelons according to their functions and roles, so as to co-ordinate the synergistic development of CBT500 enterprises, CBD100 cities.

The first echelon is the construction and energy enterprises. There are 119 enterprises on the CBT500 ranking, with a total profit of 1.7 trillion yuan, accounting for 26% of the total profit of all CBT500 enterprises. These enterprises have strengthened the foundation for national and regional development and are the key support for social

The second echelon is manufacturing enterprises, the main body of industrialization, with a total of 229 enterprises and a total profit of over 1.3 trillion yuan, accounting for 20% of the total profit of all CBT500enterprises. Manufacturing enterprises are the core of the real economy, undertaking the important mission of consolidating the industrial chain and promoting high-quality economic development.

The third echelon is the service sector companies, including transportation, commerce and communication, etc. There are 79 companies with a total profit of 790 billion yuan, accounting for 12% of the total profit of the CBT500 enterprises. The expanding scale of the service industry not only continues to pull the development of China's urbanization and marketization, but also helps upgrade China's industrial structure

The fourth echelon is the financial industry enterprises, which provide financial support for the other three echelons, with 73 enterprises and a total profit of 2.8 trillion yuan, accounting for 42% of the total profit of the CBT500 enterprises. The high-quality development of financial sector institutions has promoted the efficient allocation of resources and realized a virtuous circle with the 供资金支持, 有73家企业, 利润总额达到2.8 万亿元, 在全部上榜公司的总利润中占比达到 42%。金融业机构的高质量发展推动了资源的高 效配置,实现了与实体经济的良性循环。

百强企业群的重要使命之一是要投身于长 三角一体化、京津冀协同发展、粤港澳大湾区建 设、成渝双城经济圈建设等城市群建设的重大国 家战略, 基于四大梯队集团军的划分, 企业集群 化发展及其与城市群的合作可以形成规模经济 效应、范围经济效应和聚合效应, 可以共同创造 需求和共同扩大市场,实现共赢。企业群还可以 整合各自的优势资源联合攻关, 共享科技创新成 果,实现协同创新。

企业群和城市群合作的重点就在于做好战 略规划整合和城企协同运作。一方面、企业群和 城市群通过战略规划的整合优化,显著提升城市 预期经济价值,把蛋糕设计大;同时优化资源配 置,集中百强企业群四大梯队兵力打歼灭战,一 次战役要将城市发展推上一个大台阶, 大幅提升 城市整体经济价值,把蛋糕做大。另一方面企业 群和城市群可按照战略结盟、构建共同体等方 式,深化协同运作机制,有效减少合作中的摩擦 和交易成本、使企业和城市都能最大化自身价 值,形成双赢局面。

企业群与城市群要按照四大梯队的逻辑顺 序协同运作,首先是第一梯队,开发建设是城市 经济发展的基础,无论是老城区改造还是新区开 发都要先和第一梯队协同发展: 依次是第二梯 队,强化产业化发展,这是实体经济发展的重中 之重; 随之是第三梯队, 服务业促进市场化、城 市化全面发展: 第四梯队金融业则为所有梯队 与城市群的协同发展提供金融支持。

百强论坛将为百强企业群和百强城市群的 协同发展提供高效的合作平台。

One of the important missions of CBT500 Enterprise Cluster is to join the major national strategies of city cluster construction, such as Integrated Regional Development of The Yangtze River Delta. Coordinated Development of The Beijing-Tianjin-Hebei, Guangdong-Hong Kong-Macao Greater Bay Area Construction, and Chengdu-Chongqing Economic Circle Construction, etc. Based on the division of the four echelons, the development of enterprise clusters and cooperation with other city clusters can form the effect of economic scale, the economy of scope effect, and the aggregation effect, which can jointly create demand and jointly expand the market to achieve win-win situation. Enterprise Cluster can also integrate their respective advantageous resources for joint research, share scientific and technological innovation results, and realize collaborative innovation.

The focus of cooperation between Enterprise Cluster and City Cluster is integration of strategic planning and synergistic operation between cities and enterprises. On the one hand, Enterprise Cluster and City Cluster through the integration and optimization of strategic planning, significantly enhance the expected economic value of the city, expand the design of the cake. At the same time, we should optimize the allocation of resources, focusing on the four echelons of the CBT500 enterprise clusters to fight a battle to push the development of the city to a large stage, significantly enhance the overall economic value of the city, and make the cake bigger. On the other hand, Enterprise Cluster and City Cluster can deepen the synergistic operation mechanism in accordance with the strategic alliance, building community, etc., to effectively reduce the friction and transaction cost in the cooperation, so that enterprises and cities can maximize their own value and form a win-win situation.

Enterprise Cluster and City Clusters should operate in accordance with the logical order of the four echelons. Firstly, the first echelon, development and construction are the foundation of urban economic development, whether it is the renovation of old districts or the development of new districts need the support from the first echelon. In turn, the second echelon strengthens the industrialization development, which is the most important part of the development of real economy. The third echelon, service industry, follows, promoting the overall development of marketization and urbanization. The fourth echelon, financial industry, provides financial support for the synergistic development of all echelons and City

CBT500 Forum will provide an efficient cooperation platform for the synergistic development of CBT 500 Enterprise Cluster and CBD 100 City Cluster.





2023 年中国上市公司百强排行榜发布会 2023 China Business Top 500 Rankings News Conference

中国上市公司百强排行榜由华顿经济研究 院(时名上海经济发展研究所)首次发布于 2001年,每年发布一次。百强榜按照以利润总 额为基准的 CBT500 指标体系. 依次排列出中 国(沪深北)上市公司前500名。

由于这一指标体系不仅体现了企业的规 模, 更反映出企业的盈利能力, 集中体现了企业 发展的本质要求, 一经推出便引起学术界、企业 界和政府的热切关注与赞誉。近年来,随着我国 多层次资本市场不断发展完善和企业国际化水 平提升, 华顿经济研究院又先后编制发布了"中 国(全球)上市公司百强排行榜"、"中国(非主 板)上市公司百强排行榜"和"中国最具成长性上 市公司排行榜"。

The China Business Top 500 Rankings were first published in 2001 by Warton Economic Institute (formerly known as Shanghai Institute of Economic Development) and are published annually. The CBT500 ranks the top 500 listed companies in China (SSE, SZSE and BSE) according to the CBT500 index system, which is based on total profit.

As this index system not only reflects the scale of enterprises, but also their profitability, and the essential requirements of enterprise development, it has attracted widespread attention and praise from academics, enterprises and the government, once it was launched. In recent years, with the continuous development and improvement of multi-level capital market in China and the enhancement of the internationalization level of enterprises, Warton Economic Institute has compiled and published the "China (Globe) Business Top 500 Ranking", "China (Non-Main Board) Top 100 Ranking" and "China Most Growing Listed Companies Ranking".






